


# Enough SAID

At the 2008 SAID Annual Session, members voted to change the name of the organization from "Southern Association of Institutional Dentists" to simply SAID, with a tagline of "Special Care Advocates in Dentistry". That name was subsequently registered with the IRS, making the change final. A contest was announced at the 2009 meeting to come up with a logo more in keeping with the new name, as opposed to the map of the southern states that served the group for quite awhile. Several entries were received, and a vote was taken among members present at the 2010 meeting.
